It is further informed that an Amendment in Rule 3.2 (iv) was with reference to the grant of:

"Regular affiliation to schools run by the Govt./Govt. Aided/Kendriya Vidyalaya Sangathan (KVS)/Navodaya Vidyalaya Samiti (NVS)/Contral Tibetan Schools Organisation (CTSO)"

In view of the above amendment in the Rules and the decision taken by the Board, I have been directed to inform you that:
